Samples can be small pieces of the competition meats, wings, sausage, etc., priced at \$1 or \$2 per sample. No complete meals or beverages are to be sold as samples. In support of the fundraising for education, meat is not to be given away.

At the end of the CookOff, 85% of scrip sales will go to the cooks and 15% to the Rotary Education Foundation. Teams are also allowed to sell other BBQ products such as sauces or rubs, following the same percentage split.
